What we collect

We may collect the following information for internal purposes only:

- Name and job title
- Contact information including email address and telephone number
- Demographic information such as postal code, preferences and interests
- Other information relevant to customer surveys and/or offers

Uses made of the information

The information gathered by All Colors of Communication bvba is used to fulfill the expectations of the All Colors of Communication bvba website visitors. With this information All Colors of Communication bvba can provide the website visitors with information concerning events, meetings, seminars, job vacancies etc. that the website visitor requested or which All Colors of Communication bvba feels may interest the website visitor, where the visitor has consented to be contacted for such purposes.

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual.
